Key Information about this Study

This is a research project and participation is voluntary. The purpose is to inspire action to control pollution caused by plastics and microplastics. You are being provided with a filtration bag in which you can machine-wash your laundry to control microplastic pollution, instructions on how to use it, information about plastic pollution, and a pledge you can take to control microplastic pollution. During this project, your awareness of pollution may increase, which may cause mental distress. Your ability to control pollution by using the laundry bag may also increase, reducing mental distress. You may choose not to participate in the study at any time.

Purpose

You are being asked to be in a research study of ways to control plastic and microplastic pollution because you found out about this study through either the Ingham Conservation District or the Clinton River Watershed Council, and you are a resident of Michigan. This study is being conducted at Wayne State University in Detroit, Michigan.

Study Procedures

If you take part in the study, you will be asked to:

- o Provide your mailing address to receive a laundry bag, instructions, and information about plastic and microplastic pollution. The laundry bag is a lightweight zippered case into which fabric can be placed for machine-washing. The bag reduces friction that can dislodge microfibers that might otherwise pollute the wastewater from your home.
- o Provide your email address to receive a link to an online pledge to reduce microplastic pollution.

Benefits

- O As a participant in this research study, there will be no direct benefit for you; however, information from this study may benefit other people now or in the future. For example, methods for controlling and preventing microplastic pollution may increase.
- o Additionally, some users of laundry bags report that their clothing is protected from friction during washing and does not seem to wear out as quickly. Some users also report feeling satisfied that they are doing something that may reduce pollution.

Risks

By taking part in this study, you may experience the following risks:

 Physical risks, such as: changes in the way your laundry turns out, for example, heavily-soiled items inside a bag may not seem to get as clean; or temporary changes in machine operation like off-balance laundry loads,
