3. Updates from Projects (30 min)

Red Run- Letter Sent to EPA in February accepting the proposed \$1 million amount but that we need more funding to agree to BUI removal. Waiting to hear back.

MCPWO-

Spillway EPA and NOAA as of Feb. 63% of the available funds have been spent, 86% complete invasive removal 60% done with habitat work extra money was available to add another offline pool. Fishing pier going in on north side of the spillway at Wellington Crescent and Harper.

McBride- Waiting for DEQ permit, should be coming any day. Had a pre-con meeting on Monday and contractors are eager to get started with work. Work to begin in the next couple weeks.

Partridge Creek- Piperzack about 60% complete. All the instream habitat work has been completed.

Eric Ellis- HCMA

Wolcott the EPA grant started last fall 60 acres of restored wetland about half through and will be completed this spring/summer.

DTE tree planting grant at Wolcott. Wolcott Mill Golf Course may be repurposed into additional wetland and prairie.

Shawn Keenan, Auburn Hills- Finalizing plans submitting to the DEQ next week. Going out for bid.

Ryan Giorio, Oakland University- Consumers is coming out next month to move gas line.

St. Lawrence Cemetery - Permit approved. Tree removal in the spring and work will begin in spring.

Shelby Twp- Permits submitted for both projects work to beginspring.
