THE CLINTON RIVER WATERSHED COUNCIL OFFERS A VARIETY OF PROGRAMS AND SERVICES THROUGHOUT THE WATERSHED. EVENTS INCLUDE RIVER DAY AND CLINTON CLEAN-UP. RIVER DAY EVENTS ENCOURAGE VOLUNTEERS TO TAKE ACTION AND CELEBRATE THE RIVER AND THE WATER ENVIRONMENT. ACTIVITIES INCLUDE STREAM BANK RESTORATION, NATIVE PLANT INSTALLATION, INVASIVE SPECIES REMOVAL, RAIN GARDEN INSTALLATION, STORM DRAIN STENCILING, FISHING DERBIES, CLEAN UP ACTIVITIES, MINNOW RACES, WATER QUALITY MONITORING DEMONSTRATIONS, AND MUCH MORE. CLINTON CLEAN-UP HAS OVER 200 VOLUNTEERS THAT COLLECTED 4 TONS OF TRASH, TIRES, BUILDING MATERIALS AND OTHER DEBRIS.

THE STORM WATER EDUCATION PROGRAM IS SUPPORTED THROUGH GOVERNMENT CONTRACTS. BY THE END OF 2015, WE CONDUCTED OVER 30 PRESENTATIONS WITH AN ATTENDANCE TOTAL OF APPROXIMATELY 450 PEOPLE. THE PURPOSE OF THE PROGRAM IS TO ASSIST COMMUNITIES IN PREPARING THEIR EDUCATION REQUIREMENTS FOR THE PHASE II PERMITS FOR THE STATE OF MICHIGAN.
